



GDPR Information Clause

Pursuant to Article 13(1) and (2) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 (GDPR), we hereby inform you that:

1. The Joint Controllers of your personal data are:

Podchorążych 71/8, entered in the Register of Entrepreneurs of the National Court Register under KRS No. 0000097846, whose registration files are kept by the District Court for the Capital City of Warsaw in Warsaw, 13th Commercial Division of the National Court Register, holding NIP [Tax ID No.]: 7260000437, REGON [National Business Reg. No.]: 001377066, with share capital of PLN 50,000.00, hereinafter referred to as: the Joint Controllers.

Notwithstanding the above, to the extent related to the processing of jointly controlled data, you may exercise your rights under the GDPR against each of the Joint Controllers and contact each of the Joint Controllers independently.

3. Your personal data shall be processed in connection with video surveillance and other forms of surveillance based on Article 6(1)(f) of the GDPR. The Joint Controllers' legitimate interest in the use of video surveillance is to ensure the safety of employees, to protect property, and to maintain the confidentiality of information the disclosure of which could expose the Joint Controllers to harm.
4. Your personal data shall be disclosed to software providers, companies servicing software and hardware, auditing companies, as well as other entities when this is required by law.
5. Your personal data shall not be transferred to third countries.
6. Your personal data collected by the video surveillance system shall be processed for a period not exceeding 3 months from the date of recording, with the proviso that this period shall be extended until the final conclusion of proceedings under the law or when the Joint Controllers become aware that the data may constitute evidence in such proceedings. For all other forms of surveillance, the processing time shall be no more than one year.
7. You have the right to access your data, rectify and erase your data, restrict its processing, and the right to object to its processing.
8. You have the right to lodge a complaint with the President of the Personal Data Protection Office (ul. Stawki 2, 00-193 Warsaw), if you consider that the processing of personal data violates the law.
9. Your data shall not be subject to automated decision-making, including profiling.
